Privacy Policy

IUCN, International Union for Conservation of Nature and Natural Resources ("IUCN" or "We" or "Us") is committed to protecting your privacy and would like to ensure that you get information, content and experiences that matter to you the most.

This Privacy Policy applies to all persons who access the IUCN website "www.iucn.org", and all associated subdomains, online services and mobile applications (collectively, the "Website").

Information collected from you

IUCN may collect personal information from its Member representatives, Councillors, Commission Members, Partners, Donors, Visitors, Volunteers, Congress participants, IUCN Providers, Newsletter subscribers and other contacts.

When you visit the Website, for example when you <u>subscribe to a newsletter</u>, comment on a blog or <u>choose to donate</u> to IUCN, IUCN may collect your personal information such as designation, name, gender, position, address, telephone number, mobile number, email address, date of birth.

Information use

Legitimate purposes

IUCN uses your personal information for legitimate purposes determined when the personal information is collected such as

- when you apply to become an IUCN member;
- when you subscribe to IUCN newsletters or publications;
- when you donate to the work of IUCN;
- to provide you with specific information, support or other requested services;
- to communicate with you about a meeting, conference or event;
- to assist in your participation in IUCN activities;
- to communicate with IUCN partners;
- to engage with third party service providers;
- to get feedback or input from you;
- to conduct surveys about your opinion of current services or of potential new services that may be offered;
- for any other interactions that you may have with IUCN.

Consent

IUCN will ask for your consent prior to using your personal information where consent is considered to be the appropriate legal basis of processing.

Mailing lists

You will not be placed on any mailing list that you do not opt-in to.

Sharing information with others and transferring personal information

IUCN may provide your personal information to other IUCN offices in other regions, members and partners for legitimate business purposes and on a need-to-know basis in compliance with IUCN Privacy Policy and any other appropriate confidentiality and security measures.

IUCN may transfer your personal information to service providers who assist us in administering the Website. These service providers are bound by contractual agreements to keep your information private and secure.

Please note that whenever your personal information is transferred to processors located in countries which do not provide an adequate level of personal data protection, IUCN ensures that appropriate measures are implemented according to the applicable national and international legislation relating to data protection.

Commercial use

IUCN does not sell, rent or lease your personal information to third parties nor does not make commercial use of personal information. In case IUCN needs to use your personal information for commercial purposes in the scope of its mission, IUCN will ask for your express consent prior to any such usage.

Special categories of data

IUCN will not collect or process any special category of personal information relating to you such as information revealing racial or ethnic origin, political opinions, religious or philosophical beliefs or other beliefs of a similar nature, trade union membership, genetic data, biometric data for uniquely identifying a natural person, health, sex life or sexual orientation.

Compliance with our legal obligations

IUCN may disclose your personal information without your consent where required to do so by law or in good faith belief that such action is necessary to: (a) comply with legal process; (b) protect and defend the rights or property of IUCN; and, (c) act under exigent circumstances to protect the personal safety of users of the Website, or the public.

Your rights

You can ask to access, rectify or delete the personal information you have provided to IUCN. You may also request to be informed how your personal information is being processed, object to further processing or request restriction of processing.

Where applicable, you may also request to receive your personal information in a structured, commonly used, machine-readable format. In such cases, IUCN reserves the right to request a reasonable fee in order to deal with the request.

Storage duration and how to control your personal information

IUCN keeps personal information for as long as it is necessary to perform its activities and as is required by applicable law. You may withdraw your consent at any time. If you withdraw your consent or ask that your personal information be deleted, IUCN will disable or delete the information except where there exists another legal basis of processing such as:

- to comply with a legal obligation;
- to comply with a contractual obligation;
- for the legitimate interest of IUCN; or
- in the performance of a task carried out in the public interest or in the exercise of official authority vested in IUCN through its mandate or Statutes.

If you have subscribed to an IUCN newsletter you may ask not to continue to receive the newsletter by unsubscribing from the newsletter(s).

If you have a user account, you may control your personal information by accessing the information through the account.

Links to other sites

The Website may contain links to other external websites for your convenience and should not be construed as constituting any endorsement or approval of the external websites' content. We take reasonable care in linking external websites but have no direct control over their content or the changes that may occur to the content on those websites.

IUCN is not responsible for the privacy practices or the content of any such websites. We encourage you to familiarize yourself with the privacy

Use of cookies
